Update of Covid-Testing and Vaccination Rates

Dr. Dwight reported that the Covid Safe Schools Testing was held today with over 400 people testing in the morning and just as steady a stream of cars for the afternoon. The results of the pooled testing should be back in 24 hours and we will communicate the overall information out to the community.

SusanMary Redinger shared that she will continue to review the Covid positive cases and percentage of vaccinated in Harvard and report to the School Committee on an ongoing basis.

Covid Policy Review
